If you do not make any choice, your accrued benefits (including contributions) will be invested in accordance with the Default Investment Strategy ("DIS"). DIS is not a fund – it is a strategy that uses two constituent funds, namely the China Life Core Accumulation Fund and the China Life Age 65 Plus Fund (collectively the "DIS Funds") to automatically reduce the risk exposure as the member approaches retirement age. The DIS Funds will invest in a globally diversified manner and invest in different assets (e.g. equities, bonds, money market instruments, etc).

Part VI – Important Information 第六部 - 注意事項

- (1) The applicant must be a relevant employee or a self-employed person.
- (2) The maximum amount of Smart Easy Personal Contributions (including new contributions and rebalancing from other constituent funds) for investment in the China Life Guaranteed Return Fund or China Life Retire-Easy Guarantee Fund in each scheme year is HK\$500,000.
- (3) New contributions and rebalancing of Smart Easy Personal Contributions related to China Life Guaranteed Return Fund and China Life Retire-Easy Guarantee Fund will be subject to the acceptance of the Company, which has discretion to accept an amount beyond HK\$500,000.
- (4) Scheme members may withdraw from the Smart Easy Personal Contribution Account subject to a minimum of HK\$1,000 per transaction up to a maximum of 4 times in each scheme year at no extra charge provided that the remaining account balance at any time will not be less than HK\$1,000. A handling charge of HK\$100 will be charged by the Company on each additional withdrawal in case withdrawals by any Scheme member in each scheme year exceed the limit in this clause. No additional charges for account termination.
