Policy Payment Application Guidance Notes (Applicable to Entity Policyholder)

In order to comply with the regulatory requirements, if the Policyholder is an Entity, apart from submitting the duly completed application form¹ when applying for policy payment, the following supporting documents must be provided at the same time according to the category of the Entity (refer to categories 1 to 6 below). - a Justice of the Peace
- a trust company registered under Part VIII of the Trustees Ordinance carrying on trust business in Hong Kong
- a member of the judiciary, a solicitor, a notary public, an auditor, a professional accountant or a tax advisor practicing in Hong Kong or an equivalent jurisdiction

Besides, where a supporting document is not in Chinese or English, it must be accompanied by a Chinese or English translation certified as a true translation by a sworn translator, court translator, authorized public translator, certified translator, expert translator or official translator.
